Stephen Wagner, AI President-Elect presented on topics including Chapter Financial Management and Administration Policy (CFMAP), Governance Structure Project Team (GPST) and that AI is in the process of replacing their association management software (AMS) which will provide an enhanced user experience on the AI website. 
